Hennock Parish Council wants to make the following comments. Hennock Parish Council supports the building of affordable homes in Teign Village. We question whether this proposal meets the criteria and definition of affordable homes as in Dartmoor Local Plan 2018 – 2033



it states at the bottom of page 64 "Local needs custom and self-build housing is not affordable housing."

The proposed access is an existing passing place on a narrow lane, we couldn't find any obvious evidence of an existing gateway on google maps dated March 2022.

1. Thyme Patch, 2. Tollgate, 3. Bramble Brook, 4. Blossom According to Teignbridge's policy, names should ideally reflect local history or be in some way relevant to the area. New street names must fit with our Street Naming and Numbering policy and reasons must be given for any proposed names.

The Clerk informed the meeting that she had looked at the old Tithe maps from 1838 along with Steven Chown our local historian and have come up with these suggestions based on field names and the landowner from that area, these were unanimously agreed.

Hennock Parish Council suggests that if you require further names, we would recommend basing the names on cider apple varieties that would have been grown in the area.
