Tom Biddle and Graham Hutton from Baker Estates gave the parish council a brief update regarding Turnpike Fields development.

The salient points were:

- The site will be accessed via the existing track.
- There is a construction management plan in place which requires all vehicles over 7.5 tonnes to access the site from the east avoiding the village centre. All other vehicles will be encouraged to do the same.
- There will be a temporary surface water management strategy whilst the site is being constructed, before the permanent drainage system is completed.
- Teign Housing are the housing association who will be delivering the 18 affordable homes which will be built in 2024.
- Letters have gone out to neighbouring properties with a number to call if they have any queries or concerns about any aspects of the work. 0808 169 9116
- The new access junction on Plymouth Road and pedestrian access from Teign View will be cut through the hedge soon, but then fence off.
- It is anticipated CIL monies payable to Hennock Parish Council will equate to 15% of £1.7 million £255,000
- They have recently been informed that they will need a new substation
