Location Pitt House, Lantern Hall, Road to Pitt House

Proposal Oak (T478) - Reduce two hyperextended lateral branches in the south eastern crown aspect by 3m with a maximum cut diameter of 60mm.

Turkey Oak (T479) - Reduce the height and the spread of the crown by 2m with a maximum cut diameter of 75mm.

Oak (T480) - Reduce the sides of the east and west aspects of the crown by 2m by selective branch reduction with a maximum cut diameter of 75mm.

Our Responses: Hennoek Parish Council considered proposal 0501/23 Soda Ash Building at their Planning Committee Meeting on 23rd January 2024 at Chudleigh Knighton Village Hall, agenda item 10.2. Hennoek Parish Council objects to the proposal. Hennoek Parish Council have now had the opportunity to view all the evidence. It doesn't seem to be a dwelling to us, for example we couldn't see any evidence of windows, no running water or sewerage and no means of waste collection. Again, we note the representation uploaded on 27th November which suggests that the building has been concealed. We feel it is an inappropriate development within Dartmoor National Park.

Hennoek Parish Council considered proposal 0501/23 at their Full Parish Council Meeting on 12th December 2023 at Chudleigh Knighton Village Hall, agenda items 16.1. Hennoek Parish Council object to the proposal. In the Planning Statement that was uploaded onto the portal on 11th December it refers to lots of evidence, however this evidence isn't available on the portal. We noted the representation uploaded on 27th November which suggests the building has been concealed. This area is not an identified area for development in Dartmoor National Park.

14. TO CONSIDER ANY UPDATES OR ISSUES ARISING REGARDING TOLLGATE FARM / TURNPIKE FIELDS CHUDLEIGH KNIGHTON 22/02205/MAJ The parish council has received complaints regarding the following issues:

- Complaint about flailing of hedge on Plymouth Road on Friday 8th March
- Large amounts of water flowing down the eastern allotment track with oily residue.
- Loss of mains water in Teign View and surrounding areas on 13th March
- Construction Traffic with engines running parked in Plymouth Road very early in the morning

The Clerk was thanked for her comprehensive report SEE APPENDIX B which was noted and it was agreed that the parish council would continue to monitor the situation and report back to Baker Estates any issues arising.

16. To consider the correspondence received from Above and Beyond Care Devon following a complaint from a concerned resident about Teign Lawn, Chudleigh Knighton.

The correspondence had been circulated to councillors prior to the meeting and the Clerk explained that she had sent the resident the relevant planning documents and passed on the complaints to Above and Beyond Care Devon, who responded and the Clerk sent their response to the resident.

"In response to the concerns about Teign Lawn's home for children with disabilities and autism. I want to explain that the home has had a lot of activity in the last few weeks due to the full team attending induction and training to fulfil their roles as support workers. The home has and does accommodate all vehicles, using our drive and our parking spots at the back of the house. For your information, the young people will never be on their own; they are always supported at least with 1-1 staffing. The team will always be with the young person and support them appropriately. The home has a very large garden that the children and young people can access, so they will not need to play outside of the footprint of the property. Teign Lawn is a

home-from-home for children, so we will not be installing CCTV. Children and Young people have the right to privacy under The Human Rights Act 1989. If we need to install additional fencing for extra security for the children, then this will be completed without delay. I hope this alleviates the resident's concerns."

The Clerk informed the meeting that in response to the feedback the Teignbridge Housing Enabling Team will be holding this event online during May on 2 separate dates. The event will be repeated with one event in the morning and one in the early evening.

19. HEATHFIELD LANDFILL SITE

19.1. To note the email received from Valencia on 4th March "Valencia has temporarily closed the site to waste deliveries. A common practice with landfill sites, this will enable the team will undertake a number of landscaping and engineering work packages. These engineering works should mitigate any odour that residents may have detected. The team will communicate again once the site has re-opened. During this time, the team will continue to manage the site in accordance with its environmental permit to ensure no harm to human health or the environment."

19.2. To note the email received on 13th March from District Councillor Suzanne Sanders

The next online community liaison group meeting for the site is Monday 8th April.

19.3. To note the email received on 15th March from Andrew Turner of Camarco

"Commencing next week Valencia will undertake a planned engineering programme to install four landfill gas collection wells and associated infrastructure. This is industry best practice to enhance the long-term performance of the gas capture infrastructure, therefore increasing gas collection rates on the landfill before transferring the gas to the on-site engines for green energy generation. There may be drilling machinery visible during this time from high points surrounding the site. The Valencia team are committed to investing in the site to support its long-term management in accordance with the environmental permit. During this period Valencia does not anticipate increased odour levels."

ACTION F – No further action required at this stage the correspondence regarding Heathfield landfill was noted and we await further consultation.
